- 1. Instructions on how to claim the \$1 Resene Panel form part of these Terms and Conditions.

If the serial number and the proof of purchase do not match the details submitted by the Claimant to nzpromotions@samsung.com, the claim will be deemed invalid and will result in an ineligible claim. The Claimant will not be entitled to receive the allocated \$1 Resene Panels until the Promoter has received the required documentation and verified the claim.
- 11. Fulfilment of any Resene Panels will be processed as per normal lead times as and when the Promoter is able to supply stock. The Promoter will try to fulfil the orders as quickly as possible.
